Project Abstract: The purpose of this project is to prepare Historic Structures Reports (HSRs) for log structures located in two areas of the park. The structures include 1) the original "Old Administration Building," HS-0010 at Beaver Creek; and 2) three structures near Moran known as the former Snake River Land Company residence and office/Buffalo Dorm (HS-0117), garage (HS-0122), and blacksmith shop (HS-0121).

Colorado State University will prepare a detailed scope of work, project budget, and timeline for completion of two HSRs between project initiation in September 2006 and completion of project deliverables by December 31, 2008. This project will be used as part of one or more classes in order to train students on how to complete Historic Structures Reports and related preservation topics. All work will be overseen by professionals skilled in the areas that meet the professional qualifications outlined in NPS Director's Order 28. The HSR is the primary guide to treatment and use of a historic structure, and should follow the outline as defined in DO 28, Chapter 8: *Management of Historic and Prehistoric Structures*:
