Project Abstract: Effectively responding to the challenge of climate change requires thoughtful and coordinated responses by NPS park and regional managers as well as national program staffs that support managers with information and technical assistance. CSU organizational communication scholars will work directly with NPS national, regional, and park staffs in outlining an effective climate change response strategy. Phase 1 will include an in-depth organizational situation assessment, in which the PI will work with the NPS to:

- Identify current needs (e.g. scientific information, decision support tools, funding, partners) for effectively managing resources in an era of climate change (Working groups include: Legal & Policy, Planning, Science Research Monitoring & Technology, Resource Stewardship, Greenhouse Gas Mitigation and Sustainable Operations, and Education & Outreach)
- 2. Evaluate past performance, achievements, failures, and trends in responding to climate change.
- 3. Identify present and future opportunities for the NPS to build this capacity on a servicewide scale.
- 4. Determine the feasibility, authority, and appropriate amount of effort and resources available to implement climate change response and adaptation actions.
- 5. Develop a Climate Change Action Plan with short and long term goals and objectives to meet those goals.

Phase 2 will culminate in a fully developed Climate Change Response Strategy for the NPS. The strategy will provide clear direction, yet will be general enough to allow for regional variations in response and for future refinement and growth of the climate change program as the issue becomes better supported and integrated into NPS operations and planning.
