#### **HISTORY**

The original fire detection system (installed in 1984) was replaced in 1998 after damage by a lightening strike. The original 1983 panel was replaced with a Gamewell/Silent Knight detection system. The system is monitored by the Big Sky Security Company. Compliance for the project was completed in January of 1998 through an Assessment of Effect citing the Nationwide Programmatic Agreement allowing security and electrical systems to proceed with in-house cultural resource specialist review. This collection documents the installation of the new fire and security system for the ranch.
