Project Abstract: This project will create and Weed Management Area and organize the land owners and weed
 managers into a consortium that has the follow responsibilities:

- 1. Working with all partners (adjacent private and public landowners) establish and record management goals, weed management objectives, timelines, mandates, capabilities, budgets and other characteristics that are relevant to cooperative weed management.
- Identify attributes (including weed species, mandates, capabilities, budgets and other characteristics) that block the completion of these goals, and assign priorities to these characteristics based on the perceived severity of their impact and the difficulty of control.
- 3. Consider methods for controlling high priority species and infestations, or otherwise reducing their impact. If necessary, reprioritize based on likely impacts of control actions on target and non-target species, ecosystem functions and agricultural productivity.
- 4. Develop weed control plans based on this information, and assign implementation tasks to partners based upon their recorded capabilities and mandates.
- 5. Establish a permanent steering committee selected from among the landowner partners.
- 6. Monitor the results of management actions and evaluate the results in light of the management goals for the property.
- 7. Modify and improve control priorities, methods and plans according to the information gained through monitoring, and start the cycle again.
