Project Abstract: NPS will work cooperatively with the University of Montana in the preparation of an Ethnographic Overview and Assessment of Bent's Old Fort National Historic Site (BEOL) and the Sand Creek Massacre National Historic Site (SAND). This project will build on the work already completed in "Traditional Plant Use Study: Bent's Old Fort National Historic Site and Sand Creek Massacre National Historic Site". This project will result in an accurate foundation for interpretation of tribal history and culture based on literature review and tribal consultation. At Bent's Old Fort National Historic Site, the peoples historically associated with the Fort include the Cheyenne, Arapaho, Kiowa, Apache, Comanche, Taos Pueblo, (New) Mexican and others who may become apparent during literature review. Cheyenne and Arapaho tribes will be the only tribes consulted about regarding the Sand Creek Massacre National Historic Site. As part of this ethnographic study, the investigator will (1) document the historical and current cultural relationships between the lands and resources used by these groups at each site, including those of spiritual or religious significance, (2) summarize and evaluate existing literature, ethnographic resources and data, (3) compile copies of historical documents, lists/photographs and photocopies of artifacts of interest for living history interpretation, and oral histories relevant to the cultural groups historically associated with each site,(4) provide baseline data through site visits and oral interviews with tribal officials and representatives of cultural communities historically associated with each site, and (5) determine the potential for involvement with these groups in planning for future park programs and management activities.
