Project Abstract: The archeology survey area in Yellowstone NP is located in the northwest quarter of the 7.5 minute Lake Quadrangle and includes the Lake Developed Area (Lake Hotel, hospital, Fish Hatchery, Lake Ranger Station, Lake Lodge and Cabins). The Government area on the northwest side of the Grand Loop Road is not included in this survey. Archeological inventory is to identify historic and prehistoric archeological sites will be conducted to the standards set by the Secretary of the Interior's Standards and Guidelines for Identification of Historic Properties and the Wyoming State Historic Preservation Officers 2003 Guidelines and Standards for Class III Reports. The historic context for the Lake Developed Area has been developed by the YNP Branch of Cultural Resources and will be provided prior to field work. Additional archival research may be required. On-going tribal consultation with the affiliated tribes has yet to identify any traditional cultural properties or other ethnographic resources other than the thermal areas that has any significance to the tribes. The inventory will follow standard archeological investigation procedures accepted by the Wyoming State Historic Preservation Office. The project area will be initially examined by the field crew with personnel spaced at 30 meter intervals. Sites will be identified on the basis of two or more prehistoric artifacts, or 50 individual historic artifacts, or one or more features within 30 meters of one another. Road trash will not be considered a cultural resource. Surface artifacts, roads, and other pertinent landmarks will be mapped using a transit and stadia rod and described. Shovel tests may be conducted where the Crew Chief deems it necessary. Cultural site locations will be plotted on the appropriate USGS topographic quadrangle and photographs will be taken of the project area, site locale, and pertinent historic features.
